# Association Covenants (Vote to Update)

The Board is recommending some corrections, minor modifications and incorporation of recent amendments into the Association Declaration of Protective Covenants. The proposed changes and a ballot for members to vote will be emailed or mailed on July 3<sup>rd</sup>. Please keep an eye out for these documents and we ask you to return your ballot by August 7, 2020. Instructions for returning the ballot are described in the ballot.

### RULES & REGULATIONS CORNER

Since returning three weeks ago, it has been a delight to walk the neighborhood and see the hard work that so many people are doing to make your homes and properties look so attractive. Many of you exhibit a pride in ownership that clearly shows who we are and why we live in Eaton Pagosa Estates.

While the stay-at-home regimen has allowed us more time to focus on our properties, it seems to have made us more aware of our neighbors as well. I have received more complaints from Eaton residents about neighbor behavior than I did all of last year. I guess it comes with the job, but rules enforcement and addressing other people's grievances is not comfortable for me and I don't understand why neighbors can't just talk directly to neighbors to discuss whatever issue there may be. I would highly encourage them to do so.

Everyone here either built or moved here with the full understanding that this is an HOA with rules and restrictions that need to be followed. Some of you greatly appreciate the rules as they set us apart from other communities, elevate the appearance and standards of day-to-day living, and help to promote overall value. Some of you abhor the rules associated with HOAs but moved here anyway, perhaps against your better judgement. The whole issue of HOA rules is much like the RED-YELLOW-GREEN traffic light example described in my earlier message. We don't all interpret the rules the same way and we certainly don't all share the same opinion on even having rules in the first place. Like you I am not in agreement with all of the rules, yet I try my best to abide by them as a sign of respect for everyone in the community. If we feel strongly against any rule, then we should make the effort to remove the rule rather than violate it. Each rule applies equally to all community members. No member gets preference over any other member. There is no such thing as a worse violation of one rule versus another, although some violations carry stricter and more expensive penalties.

So first and foremost I ask all members to know the rules and follow them out of respect for others. If you choose not to follow them, then don't get upset when someone points out your infraction. Unlike many HOA's we do not have a formal enforcement committee so the first line of enforcement is neighbor to neighbor. If an infraction is bothersome to you, then talk to your neighbor directly. If it turns out that the issue is not out-of-compliance after all, discuss the matter as respectful neighbors. If those kinds of confrontations are uncomfortable to you, then talk to them anyway. As a last resort, perhaps you can talk to a board member to help resolve the issue but don't expect to keep the complaint anonymous. Remember, a rule exists because a 67% majority of the property owners voted to have the rule.

#### Rules & Regulations Continued ......

Here is a description of the non-compliance issues that were brought to my attention as currently observed in the neighborhood.

- Animals. The EPE Declaration, Art. IX Section 1 states that animals shall be kept confined to the Owners property and an area within 30' of the residence or attached by leash or other suitable control device. No animals shall be allowed to run free or become a public nuisance.
- Commercial Trucks / Construction Equipment. PLPOA rule section F.12 states that
  to preserve the residential character of the development and to prevent unsightliness,
  no commercial-type truck or heavy equipment shall be parked overnight or longer
  ...unless their presence is associated with an improvement project on that lot and
  approved by the committee.
- 3. <u>Qutside Storage</u>. EPE Declaration Art. III Section 7 states that there shall be no outside storage of RVs, travel trailers, ATVs, **utility trailers** or watercraft. All RVs, travel trailers, ATVs, utility trailers and water craft shall be stored off site or inside attached garages. Watercraft, such as canoes, kayaks and small rowboats, are exempt from the prohibition against being stored on a lot, as long as they are not visible from the roadway.
- 4. <u>Property Maintenance</u>. PLPOA rule section F.9 states that all properties shall be maintained in a state of desirability and attractiveness to protect community property values. Every lot shall be maintained to prevent it becoming unsightly by reason of vegetation growth or accumulation of rubbish or debris which may also create a fire hazard. Individual lot owners shall be responsible to maintain their properties free of noxious weeds. Tarps covering firewood must be brown, dark green or black, blue tarps are prohibited.

Please be respectful of others. If you are in violation with any of the above rules, please take steps to return to compliance.
